The 2018 Meeting of the College will Honor Dr. Ravindra Nanda

The College's 40th Annual Meeting is honoring another "Legend in Orthodontics." Our Honoree this year is Dr. Ravindra Nanda. We asked Dr. Flavio Uribe, Professor and Program Director of the Division of Orthodontics at the University of Connecticut, to share a few words about his friend and mentor.

My Friend Ravi

ife has some interesting twists and turns. Years ago, as a dental student in Colombia conducting my thesis on Class III treatment with chin cup, I remember that one of my faculty suggested that I read some papers written by some "Dr. Nanda," as he was a pioneer in craniofacial orthopedics. At that time, I never would have imagined that this same "Dr. Nanda" would become my mentor both in academics and in life. Luckily for those in the academic orthodontic world, this has not only been my experience; Dr. Nanda has been a lifelong mentor to many others drawing from his long and illustrious career, dedicated to research and education of orthodontics.

Prof, as I call him, has always been extremely kind and charismatic. At his recent retirement party, the attribute that resounded throughout all the speeches given by his friends from around the world was precisely this: his charisma. Dr. Nanda has this "X factor," this "je ne sais quoi" (something more than charisma) that makes people gravitate toward him. He lights up the room as soon as he walks in, and everyone takes notice of his presence. Another one of his remarkable traits, which many people may not be aware of, is his providential memory. It is always astonishing at our alumni reunions how Dr. Nanda remembers every detail about all of his alumni, including their graduation dates and other interesting anecdotes. Singlehandedly, he has built one of the most cohesive and supportive alumni associations consisting of so many alumni who follow and admire him. This is also a testament to how much he has given back both to the profession and to the University of Connecticut wholeheartedly throughout his lifetime.

A funny anecdote that reflects Dr. Nanda's passion for orthodontics happened just a few weeks ago. After more that 45 years of teaching and having recently announced his imminent retirement from full-time academics, we were listening to a lecture together at an orthodontic symposium. He suddenly turned to me and whispered in my ear, "why I am still paying attention to this, what I am going to use this for?" Based on the current circumstances, his logic was correct; he was not actively

practicing orthodontics anymore, so why be there? The answer in my mind was clear and simple: Dr. Nanda loves orthodontics, research, innovation, as well as the camaraderie with all of the people from around the world that he has known and mentored throughout his career.

Although Dr. Nanda is now retired from active academic life, as a world traveler, he lectures on different topics including biomechanics and novel topics in orthodontics. At the same time, he also seizes the opportunity to learn from the other prominent lecturers about the most recent innovations in our field. With his perspective as a seasoned clinician, editor of an orthodontic journal, and a professor with a wealth of historic orthodontic knowledge, he possesses a comprehensive, bird's-eye view of all of the aspects of our profession more so than any other orthodontist.

It has been a great honor and pleasure to spend approximately 20 years of my life close to a man who I have always considered to be a luminary in orthodontics. Above this, I will always be indebted to him as he has been a steadfast mentor and friend. Cheers Prof, you are truly a legend, and I am very proud to hear that the College of Diplomates of the American Board of Orthodontics will be honoring you with the Legend in Orthodontics Award.

American Board of Orthodontics Changes Examination Format

he American Board of Orthodontics is pleased to announce a change from the current Clinical Examination process to a Scenario-Based Oral Clinical Examination. This examination is designed to objectively evaluate an orthodontist's knowledge, abilities and critical thinking skills to certify orthodontists based on proficiency and clinical excellence.

The decision to change the examination format was a result of extensive research and collaboration with leaders in the industry, reviews of other specialty board examinations, and input from educators. This process identified the need to improve the testing methodology to assess clinical proficiency and critical thinking skills to ensure each orthodontist has developed exceptional expertise and is capable of providing the highest level of patient care. The new examination offers an improved testing method that compliments what residents are learning in their programs.

The examination will be composed of four domains for assessment:

- 👃 Data Gathering and Diagnosis
- Treatment Objectives and Planning
- 🙏 Treatment Implementation and Management
- Critical Analysis and Outcomes Assessment

In order to transition into the new examination format, the ABO will continue to offer the traditional case-based exam by petition only in September 2018 and February 2019. Petitions must be approved prior to registration. The ABO will not be accepting electronic case submission for these examinations. Pre and post physical models will be required (no digital models accepted) along with the traditional notebook style submission. The Scenario-based Oral Clinical Examination will also be offered in February 2019. The November 2019 examination will only include the new examination format.

Dr. Larry P. Tadlock Installed as ABO President

he American Board of Orthodontics (ABO) installed Larry P. Tadlock, D.D.S., M.S., of Colleyville, Texas, as the 2018-2019 president.



Each ABO director represents one of the eight constituent organizations of the AAO and serves an eight-year term, which culminates in the position of the president. The ABO directors are responsible for establishing policy with regard to the board certification of specialists in orthodontics. During his tenure as an ABO director, Dr. Tadlock has rep-

resented the Southwestern Society of Orthodontists (SWSO). He also serves the ABO as chair of the Finance Committee, and as the ABO liaison to numerous professional organizations, including the American Association of Orthodontists, the College of Diplomates of the ABO, the Graduate Orthodontic Resident Program (GORP), the World Federation of Orthodontists (WFO) and the Society of Educators (SOE).

Dr. Tadlock is Program Director of the Department of Orthodontics at Texas A&M University College of Dentistry. He earned his dental

degree from the Baylor College of Dentistry in 1984 and obtained his orthodontic certificate and Master's degree in Biomedical Sciences from The University of Texas Health Science Center at Houston in 1988. He has been board certified by the ABO since 1995.

Dr. Tadlock is a member of numerous professional organizations, including Angle Southwest, the southwest component of the Edward H. Angle Society of Orthodontists, the AAO, the SWSO, and the Texas Association of Orthodontists. He is a fellow of the American College of Dentists, a member of the College of Diplomates of the American Board of Orthodontics (CDABO), and a member of the Texas Orthodontic Study Club, formerly known as the Tweed Orthodontic Study Group of Texas. He is also a past president of the SWSO and the University of Texas Orthodontic Alumni Association. He has received numerous awards for contributions to the orthodontic specialty. The most notable include the 2016 Martin Dewey Memorial Award from the SWSO, the 2009 Yellen-Schoverling Award from the University of Texas Orthodontic Alumni Association, and the 2008 Earl E. and Wilma S. Shepard Award of Distinguished Service from the ABO.

In Memoriam: College Past President O.B. Vaughan

y grandfather, O.B. Vaughan, was given credit for being many things: a gentleman, compassionate, role model, perpetual student, caring. Growing up around him, I certainly observed all of that. But the quality that I remember most was his intensity. A life like his does not happen by accident. He would observe, filter information to its essence, and then act. What followed was always decisive and usually swift. He was intentional in each aspect of his life, every day.

O.B. Vaughan was defined by his goals. He would personally go above and beyond to help others. He pushed others to achieve their goals, encouraged peers to become board certified, and made sure others received the accolades they deserved. He was as devoted to others improvement as he was to his own.

Still, the things that do not get said about him are just as important as what is widely known. Not all his decisions turned out the way he intended. The spectacular thing was that he was not deterred from his ultimate goal with a set-back. He got up the next day, developed a new plan and took action. Regardless of how it might have been perceived, his passion for improvement drove him to do more – to focus his energies on improving himself and serving others.

When I was in dental school at UTHSCSA and he was a lecturer in the orthodontic department, he would drive into San Antonio from Corpus early the evening before and we would have dinner. These were some of the best memories – and not because of anything we talked about – we were a normal granddaughter and grandfather having dinner – I always knew he would come have dinner with me every month, without fail. I could count on him.

My grandfather would tell me about the deep and meaningful friendships he forged over a multitude of orthodontic meetings. He was devoted to maintaining those associations throughout his life and took every opportunity to visit or write to friends. It was a dream of his for all orthodontists to be united by having attained board certification. Those fortunate enough to know him knew he was more than a wise and caring person. His relationships, actions, and life demonstrated his steady path of reaching goals and pushing boundaries.
