Please invite a board eligible colleague to Big Sky. A non-diplomate or non-College member can attend one Annual Meeting at the same rate as a College member's registration fee.



College Events at AAO a Success!

THE COLLEGE recently held several events at the 2008 AAO Annual Session in Denver.

The review courses for the ABO Written and Clinical Exam were well attended. One Written Exam Course, three



Model Measurement Courses and seven Discrepancy Index sessions were held with a total of 100 doctors participating. The College introduced a review course for the ABO Board Case Oral Exam (BCOE). This was given as a pilot to five doctors who volunteered. The BCOE Review Course was very successful and therefore will be offered at the 2009 AAO Annual Session in Boston along with Model Measurement and Discrepancy Index courses.

Drs. Peter Buschang and Larry Tadlock taught the Written Exam review course. Dr. Dick Ridgley, The College's continuing education director, was lead instructor in the Clinical Exam review courses with assistance from Drs. Samir Bishara, Walter Buchsieb, John Carter,

Rodney Hyduk and Dick Ridgley, with the help of the ABO and Dr. James McNamara, have arranged for Model Measurement, Discrepancy Index and Board Case Oral Examination prep courses to be presented at the upcoming GORP meeting in August.

A pilot prep course program with presentations at three residency training programs by Dick Ridgley has been completed. Results are being analyzed and a definitive long-term plan formulated.

With Initial Certification Examinations (ICE) being the future, universities,

AAO Annual Session and constituent Annual Session prep courses will provide a valuable first-step resource to those seeking certification.

- A combined Model Measurement, Discrepancy Index and Board Case Oral Examination prep course will be presented at the GORP Meeting in August.

• A congratulatory post card with information about the College is now included with the ABO's letter that informs the candidates they have successfully completed the certification process.

College Founder and Past President In Memoriam Tribute to William Floyd Stutts, D.D.S. 12/14/1926 – 01/23/2008

DR. BILL STUTTS was born in Tuscaloosa, Alabama to Floyd Delma Stutts and Rubye Earline Park Stutts and spent his early years in Alabama. He attended the University of Alabama for a short time before joining the U.S. Merchant Marine late in World War II. After the war he returned to the University and completed his bachelor's degree in 1948.

In 1952 he earned his D.D.S. degree from Northwestern University. While in Chicago he met and married Marilyn Martin from El Dorado, Arkansas. He then resumed his military career by serving as a lieutenant in the U.S. Air Force Dental Corps during the Korean War. After his honorable discharge with the rank of captain in 1955, he moved to Dallas to complete a three-year preceptorship in orthodontics under **Dr. Robert Gaylord**.

Following his preceptorship, Dr. Stutts established his practice in north Dallas. He remained in practice until 2006. He also volunteered his time and services to the Children's Medical Center in Dallas for almost ten years.

The integrity of orthodontics as a specialty was very important to Dr. Stutts. His strong belief in that integrity led him to become involved in orthodontic organizations. He served in almost every significant office of the Southwestern Society of Orthodontists, of which he was president from 1977-1978. From 1978-1979 he was president of the Texas Association of Orthodontists. In addition, Bill served as president of the Texas Society of Dentistry for Children from 1979-1980, and for several years he served as secretary-treasurer of the Texas Section of the International College of Dentists. He was also a member of the American College of Dentists, and he served on

the Board of Directors of the American Dental Association's Political Action Committee from 1989-1990.

Bill was among the seven orthodontists who founded the College of Diplomates of the American Board of Orthodontics. He served as president of the College of Diplomates in 1982-1983. In 1995 the

College established its Foundation, and from its beginning Bill served as the Foundation's secretary-treasurer. At the time of his death he was secretarytreasurer emeritus. For all his services to the College, he was awarded the highest honor, the Founders Award.

He served on the AAO Board of Trustees from 1983 through 1991 and on the Board of Directors of the AAO Foundation from 1988 to 1990. During his time on the AAO Board of Trustees he fostered the use of technology among board members, encouraging them to use E-mail in its earliest form. Bill served the AAO as president from 1989-1990. During his presidency, he received distinguished alumni recognitions from the University of Alabama and Northwestern University as well as commendations from city, state, and federal elected officials for his distinguished service, outstanding achievements and meaningful contributions to his profession. The AAO Annual Session held in Washington D.C. during Bill's tenure as

President, represented a major step in the greater inclusion of orthodontists and professors from around the world



in the work of the AAO. His travels and involvement in organized orthodontics, including the World Federation of Orthodontists, the European Orthodontic Society, and other organizations allowed him to meet colleagues from around the world. He was very internationally oriented and had great rapport with outstanding

orthodontists worldwide. He traveled frequently and lectured overseas. He was very proud of his colleagues from abroad and he valued their friendship.

At orthodontic conferences Bill was often seen with a camera around his neck, capturing the camaraderie on film. At these meetings, he was frequently the "unofficial," official photographer. He would send photos to the respective parties and enjoyed the contact that photography provided for him with his colleagues at the conferences.

Thinking of others came naturally to Bill. His wonderful family was first on his list, but he cherished his friends and patients as well. Dr. Stutts is survived by his wife of 56 years, Marilyn; son Bill Stutts Jr. and wife Susan of Austin, Texas; daughter Janet Stutts of Dallas, Texas; daughter Debbie Cooper and husband John of Garland, Texas; daughter Pam Dinger and husband Tim of Siloam Springs, Arkansas; son Mike Stutts of Dallas, Texas; brother, Herb Stutts and wife Marilyn of Potomac, Maryland; aunt Mary Park of Tuscaloosa, Alabama; and grandchildren--- Brad, Brian and Ben Cooper, and Park, Sam, Luke and Caroline Dinger.

The ABO is pleased to announce that there are more than 5,000 Diplomates worldwide comprising 52% of the AAO active membership.

In February, the ABO held its Clinical Examination in Dallas, Texas, for those orthodontists striving to become boardcertified or recertified. This examination session included the First Recertification Examination for orthodontists who selected the Gateway Offer, the Initial Certification Examination for orthodontists who recently completed their postdoctoral programs, and the traditional Clinical Examination for orthodontists completing the Option I or Option II certification pathways. The ABO certified 88 of the 111 examinees.

Eighteen orthodontists successfully presented cases for the Initial Certification Examination (ICE). These individuals finished their board cases during their postdoctoral programs. There were 26 orthodontists who successfully passed the First Recertification Examination, thereby maintaining their certification. The remaining examinees were pursuing the Option I or Option II certification pathways and successfully completed the traditional Clinical Examination.

ABO REPORT

With the rising number of orthodontists seeking certification and recertification, the ABO is taking steps to meet the potentially increased demand for future clinical examinations. Therefore, the ABO trained eight new examiners during its Clinical Examination in February in Dallas. Each of the new examiners have successfully completed recertification examinations and hail from different parts of the United States, ensuring that all eight of the constituent organizations are well represented.

Under the new certification model, the ABO will examine and certify orthodontists immediately following their graduation from an accredited postdoctoral orthodontic program, provided they have passed the Written Examination. To maintain their diplomate status, these individuals must complete periodic reexaminations throughout their careers.

Although February 2008 marks the last time the ABO will offer the Clinical Examination for traditional certification pathways, an option still exists for those practicing orthodontists who are interested in becoming board certified. These individuals can take the "Beginning Certification Examination" which requires the same case presentation criteria as the First Recertification Examination. Upon successful completion, they will receive a 10-year time-limited certificate.

The ABO offered the Written Examination on April 21-25, 2008 at Pearson VUE Centers throughout the U.S. and Canada and is happy to report that there were 362 participants with a 94% pass rate. The ABO will now be able to provide consolidated quintiles for each of the four modules, as well as the individual candidate's quintiles by section, including the percent of items answered correctly.

The ABO will present another Educators Symposium on November 2, 2008 at the St. Louis Airport Marriott

The Foundation finances are solid shown by a fiscal year ending (April 30, 2008) balance of \$231,259.77.


Over the years the foundation, with strong guidance from **Drs. Bill**


to contribute to the Foundation. We welcome and need your financial support. You can earmark your check to go to the "continuing education project" and I can assure you it will be well used.

LAST YEAR THE

Council approved a concept of creating a position of "Director of Continuing Education". I was asked and agreed to accept this position. The goal is to develop an avenue into the orthodontic programs to present modified versions of our successful clinical examination prep courses
