**RECENT ACTIVITIES** that continue to push the College forward include the following:

- To save printing and postage costs, the College office will continue to periodically send e-mail blasts to members and non-member diplomates to keep them informed of College activities and to encourage non-members to join the College.
- This *Diplomate* will be mailed to all non-member diplomates and students to inform them of the College and College activities.
- An ad-hoc committee on Annual Meeting sponsorship will propose a change in policy at the July 2009 business meeting.
- A combined Model Measurement, Discrepancy Index & Cast Evaluation and "Mock" Board Case Oral Examination preparatory course was highly successful at the 2008 GORP meeting and the College has been invited

back to give the presentation at the upcoming 2009 GORP meeting.

- The College continues to offer and bring the board certification preparatory courses to residents at their school. Courses have been presented at eleven orthodontic programs. We are working to confirm a date with several more schools that have expressed interest.
- Advertisement of the Step Brochure in the *Diplomate* generated new orders. We will continue to advertise this brochure in future issues of the *Diplomate*.
- The members of the College Council teach a variety of ABO certification preparatory courses over a four-day time period during the AAO Annual Session.
- The new "Mock" Board Case Oral Exam certification course was added to the course schedule this year at the AAO meeting in Boston. See article "Events at the AAO".

# Sponsorship for the College's Annual Meeting

The College Council is revisiting the policy of accepting sponsorship for their annual summer meeting. Standing motions to the members in the past to allow sponsorship have not been approved. A new motion to change the policy will be introduced to the members at the 2009 Annual Summer Meeting in Kohler, Wisconsin. An advantage of sponsorship would be to reduce meeting registration fees. A disadvantage is that the College summer meeting would not be independent of commercial ties.

The last College of Diplomates of the American Board of Orthodontics Foundation (CDABOF) board meeting was held on May 4, 2009 in Boston, MA. At the May 2008 meeting, the Board increased its allocation for the College education program from \$10,000 per year to \$15,000 per year for the next two years. The board will continue to contribute funds to the Ray Thurow lecture at the College's Annual Summer Meeting. Please provide the Board with suggestions for future projects.

Bylaw changes were presented and adopted to put the Foundation's Bylaws in line with those of the College. Thank you to **Dr. Bob Staley** and his committee for their work on this project.

**Dr. Richard Ridgley** is working with the AAO regarding the possibility of using the *AAO Bulletin* to promote the College's courses. Due to the changes implemented by the American Board of Orthodontics, our mission has not changed, but the manner in which preparatory courses are delivered has changed.

A donation card was included with the College's dues statement sent to all members in September. The total donation amount received to date this year is \$8,810. The CDABOF money market value is \$221,579.52.

# The College of Diplomates 2009 Annual Summer Meeting in Kohler, Wisconsin, July 17-21



### **CONTINUING EDUCATION**

**THE DEPARTMENT** of continuing education has been very busy. The College Council, with financial support from your Foundation, approved ABO examination preparatory courses to be made available to orthodontic departments. Currently we have completed courses at the following departments: Montefiore, St. Barnabas, University of Oklahoma, University of Maryland, University of Tennessee, Baylor College of Dentistry, University of Illinois at Chicago, Boston University Medical Center, University of Alabama, Arizona School of Dentistry, and University of Colorado at Denver. Over 200 residents participated out of the 11 departments. Our courses reach out to the residents and review the use of the measuring gauge in case evaluation, discrepancy index and board case oral examination. Our courses have received great reviews and we are looking forward to presenting these important courses to additional departments.

During the 2009 AAO Annual
Session in Boston the College taught
143 people who took a total of 237
courses. Nineteen instructors taught 98
orthodontists the Model Measurement
course, 79 orthodontists the Discrepancy
Index course and 23 orthodontists
the newest course, "Mock" Board
Case Oral Exam. All of the College
councilors participated in teaching these

courses. Many thanks to everyone who participated in making this the most successful teaching session. See page 1 for list of instructors.

### **ABO REPORT**

### THE AMERICAN BOARD of

Orthodontics (ABO) continues to enjoy a productive and collegial relationship with the College, forged by a mutual understanding of the

value of certification.

This is a unique year for our specialty's leadership as the presidents of the College, the AAO and the ABO are all members of the MASO constituency. At a recent meeting among incoming College President **Dr. Philip Markin**, AAO President

**Dr. Robert Bray** and myself, a number of collateral objectives were defined for future implementation.

One of these objectives is to partner with the College to collectively convey the value of the Initial Certification Exam (ICE). There is no question that the future of the specialty rests within our youngest members. Following the conclusion of the ABO's Gateway Offer in 2007, 36% of the AAO membership was 47 years old or younger. Of that younger AAO membership, 74% are now ABO certified. This indicates that the younger generation of orthodontists considers board certification a worthwhile endeavor.

The College's efforts in assisting and motivating the young orthodontist toward board certification strengthen our specialty. We must convey that early certification as well as membership in the College elevates the standard of orthodontic care. College membership encourages not only recertification but also avails a career of continuing education and fraternity. I envision full

synergy between incoming College President Philip Markin and the ABO Executive Committee in striving toward communication of these benefits. We are in the process of

developing the mechanism for that initiative.

The College's preparatory courses for our examination processes continue to provide not only valuable support to board examinees, but also serve as a critique of our testing processes. The genesis of several of the modifications within our examinations

has been generated from questions posed by the College's instructors and participants.

Many of the examiners at the ABO Clinical Examination are members of the College. The volunteer faculty of the College continues to be the Board's greatest advocate in preparing examinees for the written and clinical examinations. The preparatory course participants praise the College's effort unconditionally. We respect and treasure the College as our genuine "educational arm."

The ABO and the College are collaborating to allow College members to voluntarily recertify at the summer CDABO meetings. The College is developing the details of the program and will hopefully offer this option by the summer of 2010. This service will further the partnership between our two organizations.

Extra effort from College members is obvious. For example, the superb Discrepancy Index (DI) and Cast Radiographic Evaluation (CRE) booklets developed by

**Dr. John Carter** are invaluable to anyone interested in the clinical examination. The effort of Dr. John Kanyusik has been monumental in propelling the ABO mission, as John remains a "can-do guy" in any capacity on behalf of the College and the ABO. Dr. Richard "Dick" **Ridgley's** devotion to the preparatory courses offered across the nation is valued and appreciated. These three gentlemen were awarded the ABO's Special Recognition Award at the AAO's Annual Session in Boston for their enduring devotion to our organizations and to the specialty.

There is no question that synergy between our organizations will not only address our specialty's problems but will also propel us with success into the future. I look forward to serving you and the profession in this collaborative effort and remain available should you have additional suggestions regarding our continued efforts.

AS BOTH THE 2009-10 president of the AAO and the liaison from the AAO Board of Trustees (BOT) to CDABO, I look forward to the coming year of service to our members and patients.

As you may know,
I am a member of the
Middle Atlantic Society
of Orthodontists (MASO).
In an interesting turn of
events, this year's presidents
of CDABO and the ABO,
Dr. Philip Markin and Dr.
Peter Greco, respectively,
are also from MASO. I
expect this will bode well
for the highest level of

cooperation among our organizations. We in fact had a meeting in Boston during the AAO's Annual Session where the three of us shared our thoughts for the year as well as future meetings.

The AAO BOT is immensely appreciative of the College's efforts to increase the number of AAO members who have achieved ABO certification. What a success story! An astounding 52 percent of AAO members have achieved board certification—up from 35% of AAO membership just three short years ago. This elevates our beloved specialty—particularly in the minds of consumers. While consumers may not know what it means for an orthodontist to be board-certified, they know it's a good thing. Your educational program is the best and we thank you for your efforts in making all orthodontics better.

Consumer education continues to be among the critical issues being addressed by the AAO. The Public Awareness Campaign is heading into its fourth year. The campaign establishes trust in the AAO member/orthodontic specialist so that when the time comes for orthodontic treatment, the consumer can make an informed decision about who

provides that treatment. The campaign has successfully made hundreds of thousands of consumers aware of our unique educational qualifications through ads aimed at our target audience

placed on cable TV, on the Internet, in magazines and on satellite radio. To date, the campaign has driven more than 1.5 million first-time visitors to braces.org. Many visitors use the "Find an Orthodontist" service to locate AAO members near them. Collectively, our names have been given out more than 5 million times

since the campaign launched in October 2006. I checked my own numbers on the member Web site and my contact information has been given out 1,390 times since the campaign began. I invite you to check your numbers through AAOmembers.org.

Other critical issues have been the focus of AAO activity for the last few years, and will continue to be at the forefront. They include the recruitment and retention of orthodontic educators; advocacy/governmental affairs; relationships with the ADA and other healthcare organizations; international orthodontic issues; and volunteer leadership development. The AAO is committing a host of resources in all of these important areas.

In addition, the BOT recommended adoption of a seventh critical issue, which was approved by the 2009 House of Delegates: practice management. The recent downturn in the economy impacted many of our members. The AAO responded quickly with Webinars that addressed a variety of practice management aspects. Webinars and other practice management resources will continue to be made available to

AAO members. Practice management is always part of the program at Annual Session, and the 2010 meeting in Washington, D.C., themed "Passion for Excellence," will feature it prominently. 
