Bylaw Changes Pass By Lars Keso, Chair

The following revisions were passed at the annual business meeting:

Amendments to Article IV

1. Background: Sturgis, 4th Edition, states, "an organization has an inherent right to remove an officer or director from office for valid cause." The common *valid* causes for removal are listed in the manual (pages 173-174).

2. Addition of Section 7

Removal of Officers and Councilors: "The Executive Council, by unanimous vote of the remaining members, may remove an officer or councilor from office for cause."

CDABO Foundation Report by John W. M. Carter

The Foundation was established to support the vision of promoting ABO certification and creating awareness of the value of certification.

Its primary mission is to aid the College in increasing the percentage of ABO certified orthodontists. Towards this endeavor, several projects are being funded, including paying for one speaker's honorarium at the annual CDABO July meeting (designated as the Ray Thurow Honorary Lecture) and aiding the College in the development of its Web site.

The Foundation Board has established levels of recognition: Memorial \$50, First Step \$100, Second Phase \$250, King Step \$1,000, Giant Step \$2,500, Mega Step \$5,000, Astro Step \$7,500, and A Step Beyond \$10,000.

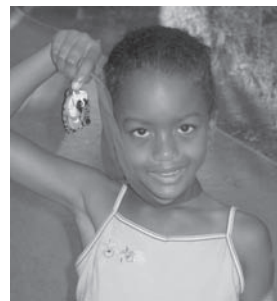

CDABO had a wonderful "reunion of Diplomates" July 17 - 21 in New Mexico. A total of 451 were present as 173 doctors and their families attended. It was great to see so many young families as 75 attendees were ages 18 and younger. We also had an opportunity to welcome 25 first-time attendee doctors.

Our annual meeting started with flair as Tucker and Donna Haltom hosted a pre-meeting evening at the Santa Fe Opera on Friday. Saturday Dick Ridgley and Walter Buchsieb presented a model measurement course for attendees interested in recertification.

Sunday evening's welcome reception included a Flamenco guitarist, Southwest cuisine buffet, authentic Indian market and Council presentations.

Monday morning was our traditional breakfast for doctors and families with opening ceremonies and award presentations. John Kanyusik was presented the Honorary Chair's medallion. The meeting was dedicated to Elbert "EB" King for his pioneering efforts to promote orthodontics and board certification in the Southwest. The highest of CDABO honors, the Founder's Award, was presented to Bill Stutts.
