knowledge base through the introduction of new techniques, technologies and products. It is a privilege to serve as the 2013-14 president of the AAO, and to provide the annual AAO Report to members of The College. The AAO supports The College's efforts to encourage excellence in orthodontic care and certification of orthodontists by the American Board of Orthodontics.

By virtue of being an orthodontist, we have each committed to being lifelong learners. The more we know, the better we are in delivering the high quality care our patients expect and deserve. Programs such as those offered at The College's summer meetings, as well as AAO's educational events, help to satisfy our quest for knowledge. As I meet orthodontists from around the world, one thing that has become evident is that new and younger orthodontists want and need mentorship. Please consider mentoring those who are new to our specialty by inviting them to attend a future summer meeting of The College with you.

I regret that I am unable to attend this summer's meeting in Bermuda, but ask you to welcome Dr. Robert Varner, AAO's president-elect, who looks forward to joining you. I wish you a very successful meeting, and I hope that all of you enjoy your time in Bermuda.

The AAO was pleased to launch a new and much improved member website, aaoinfo.org, in March. Navigation was designed to make finding what you need easier and faster. In addition, the look and feel of the site reflects the AAO's *My Life. My Smile. My Orthodontist.** brand. One of the site's new features is the interactive "Communities" section. Here members from all over the world can converse on many topics, comment on news and information from the AAO, share opinions, offer tips and collaborate with a network of colleagues. The robust Practice Management section of the site houses marketing materials, patient education materials, the Office Design Manual, free practice management forms/releases and other services to aid you in efficiently managing your practice.

Our effort to educate consumers about orthodontic care by orthodontists continues. Known as the Consumer Awareness Program (CAP), the campaign also carries the name *My Life. My Smile. My Orthodontist.** The campaign seeks to establish the "brand" in the minds of consumers so that when they see the AAO logo, or see the images, colors and fonts used in the campaign, they know it represents orthodontists, and that orthodontists are experts when it comes to orthodontic care.

The CAP uses paid advertising coordinated with public relations outreach to educate consumers. All messaging drives consumers to the public website, where they can learn more about orthodontic treatment, and locate nearby AAO members using the "Find an Orthodontist" service. This service displays the ABO logo for those who are Diplomates of the American Board of Orthodontics. I encourage you to be sure your contact information on file with the AAO is current; this will facilitate consumers' ability to find you. In particular, be sure the AAO has your practice website address. The URL will appear with your other contact information when you are "found," and this will enable interested consumers to jump from the AAO site to your site. If your contact information needs to be updated, visit aaoinfo. org, login, and click on "My AAO" (next to your name on the home

page), then click on the "AAO Member Profile" tab.

The *My Life. My Smile. My Orthodontist.** campaign is evolving. In the coming year, you will see a focus on the special relationship orthodontists have with our patients. It has been skillfully captured in new ads and TV commercials.

A benefit of the member-supported CAP is members' ability to use the CAP materials to promote themselves and their practices. Materials may be downloaded from aaoinfo.org and may be customized by members or their vendors. Using these materials locally helps consumers connect you as an AAO member orthodontist with the AAO advertising they see nationally. You are the AAO brand!

Members can access more than 20 free AAO-branded videos to use on practice websites, social media pages, or to run on a continuous loop in a waiting room. Videos are posted on aaoinfo.org.

While educating consumers is a critical key to the future of our s pecialty and the health of members' practices, so are advocacy and government affairs. The actions taken by legislators in Washington, D.C. can have a profound effect on our practices. Therefore, the AAO monitors legislation that could impact AAO members as healthcare providers and owners of small businesses, or affect the ability of patients to afford care. We enlist the aid of the ADA and sister dental specialty organizations to form coalitions, when appropriate, and speak with one voice to protect our profession and our patients. For example, the AAO formed a coalition that was instrumental in saving Flexible Spending Accounts (FSAs), which were in danger of being discontinued altogether as legislation known as the Patient Protection and Affordable Care Act was being crafted. FSAs allow consumers to use pre-tax dollars to pay for healthcare, including orthodontic treatment. The good news was that this important benefit, one that many patients use when paying for their orthodontic care, was rescued. With good news came not-so-good news: as of January 1, 2013, the benefit was capped at \$2,500 annually. The AAO is working toward raising or eliminating the cap. Similarly, the AAO is working to repeal another component of the patient Protection and Affordable Care Act, the Medical Device Tax, to keep orthodontic care as affordable as possible for patients.

Your AAO is busy on these fronts and many others to help you bring your patients the highest quality of accessible, affordable orthodontic care.

As you plan your professional meeting attendance for 2014, I invite you to attend the AAO Annual Session in New Orleans. The five-day meeting opens April 25, 2014. We will have Big Smiles in the Big Easy! This premier global event will feature leading clinicians and researchers on the Doctors' Program. Kenny Loggins will entertain at the Opening Ceremonies, gridiron superstar Peyton Manning will deliver the keynote address at the Excellence in Orthodontics Awards Luncheon, and a gala event will be held at the U.S. Freedom Pavilion of the National WWII Museum. Registration opens in November on aaoinfo.org.

ABO REPORT

The primary purpose of the ABO is to elevate the level of orthodontic care for the public by encouraging excellence in clinical practice and specialty education. Toward this end, the united efforts between the ABO and CDABO become more important as we formulate actions.

A joint meeting with CDABO and the ABO was held in Philadelphia. One of the primary discussions was about the Gateway program and those applicants that failed to carry through on the opportunity for certification. It was consensus that any efforts to get these individuals to reconsider certification would be highly beneficial not only for CDABO and ABO, but for the public well-being. These potential examinees do not need to retake the written exam and could apply for the BGCE to secure certification.

Privacy matters would preclude the ABO from supplying the contact information to CDABO thus it was determined that the ABO would contact this particular group to see if they would like a follow-up on their options. In turn the ABO could then forward this information to CDABO for contact purposes.

The Initial Certification Exam (ICE) Advocacy Program has been gratifyingly successful. This joint venture between our organizations had involved numerous individuals from both organizations. ICE is believed to be the premier pathway to board certification. Advocacy for the ICE program is spearheaded by Drs. Eladio Deleon and John Kanyusik with committee members Drs. Steve Dugoni and Larry Tadlock. Visits to accredited programs to encourage participation in ICE, both residents and faculty have recognized the opportunities that are available to them. Approximately every two years advocates plan to visit accredited orthodontic programs.

The banking of cases has proven to be a viable way to encourage participation in certification. We are well into our second year of this process and it remains workable and well accepted by both the examinees and ABO.

Since the most recent CDABO meeting in Bar Harbor, Michigan, we have given three Clinical Examinations. These examinations all took place at the Testing Center in St. Louis in August and November of 2012 and February of 2013. There were 357 examinees examined. At the time of this writing, the next Clinical Examination will be given in June of 2013 in St. Louis.

It goes without saying that Clinical Examinations would not run as smoothly if not for the dedicated examiners and ABO Staff. Most examiners are CDABO members. The educational thrust of CDABO is vital to giving secure and eager confidence to possible examinees.

It is within the next 10 years that the board certified orthodontists via ICE, BGCE, and Gateways will need to recertify. Visit our website at www.americanboardortho.com. The following is the requirements for the First recertification:

First Recertification Examination

This clinical examination will follow successful completion of the clinical examination of all time-limited certification pathways. It can be taken no earlier than two (2) years prior to the expiration date of the current certificate. The time-limited certificate will expire in ten (10) years. Any remaining time on your current certificate will be added to the new certificate.

1. Patient Source

Three cases treated by the examinee from their clinical orthodontic practice are required.* Cases must be initiated within one's current certification time frame or within the past ten years.

*Exception – Full-time orthodontic educators, who have graduated from an ADA accredited advanced educational program in orthodontics within the U.S. or Canada, may present up to three (3) cases that the educator directly supervised while teaching within an accredited orthodontic graduate program. The supervised cases may not include a case that will be presented to the ABO by a resident of the orthodontic program.

Individual consideration will be given to the full-time educator, who has graduated from an ADA accredited advanced education program in orthodontics within the U.S. or Canada, and who is affiliated with a graduate orthodontic program outside the U.S. and Canada.

2. ICE Pathway -

Components and Criteria of the First Recertification Exam

- a. Case Report Examination (CRE)
- b. Case Report Oral Examination (CROE)
- c. Three (3) cases, presented in-person:
 - + two (2) cases with a DI of twenty (20) or greater
 - one (1) case with a DI of ten (10) or greater
 - ♣ At least one (1) non-surgical case with a bilateral or unilateral full-step Class II molar relationship corrected to a Class I molar and canine relationship (identified as "Class II Case").
 - No more than one (1) case treated with orthognathic surgery (identified as "Surgical Case"). Note that a surgical case is not required. Any surgical case must include interim (pre-surgical) records.

3. Other Time-Limited Pathways – Components and Criteria of the First Recertification Exam

- a. Case Report Examination (CRE)
- b. Three (3) cases, presented by-mail:
 - + two (2) cases with a DI of twenty (20) or greater
 - one (1) case with a DI of ten (10) or greater
 - ◆ No more than one (1) case treated with orthognathic surgery (identified as "Surgical Case"). Note that a surgical case is not required. Any surgical case must include interim (pre-surgical) records.

2013 CDABO Award Winner Chosen

The winner of the prestigious CDABO Case Report Award for 2013 was announced by *AJO-DO* Editor-in-Chief Vincent G. Kokich at the Annual CDABO Luncheon in conjunction with the AAO annual session in Philadelphia, Pennsylvania on May 4, 2013.

The CDABO Case Report Award is given annually to the most outstanding case report published during the previous year in the *AJO-DO*. This year five officers of the college participated as judges, and the selection was based upon:

- Uniqueness of the original clinical problem
- Quality of the records
- Quality of the orthodontic treatment
- Quality and clarity of the writing

This award is sponsored by the College of Diplomates of the American Board of Orthodontics and includes a certificate as well as a \$1500.00 award to the recipient. The 2013 CDABO Case Report Award goes to Dr. Hiroshi Mimura and his coauthor for their case report, "Orthodontic reconstruction with autotransplantation and bone grafting after an

automobile accident", which was published in the April 2012 Supplement issue of the journal. The treatment rendered in this case was outstanding and showed the value of thinking outside the box when treating a patient who had lost six anterior teeth in an accident at the age of 10 years. Due to the clever treatment plan involving the autotransplantation of two mandibular premolars to the maxillary central incisor sites and a bone graft, the patient only required two lateral incisor implants to complete the treatment.

Dr. Mimura received his DDS from Nihon University in 1985, and his Ph.D from Tokyo Medical and Dental University in 1989. He has been awarded fellowship in the Royal College of Surgeons of Edinburgh, and is a Diplomate of both the European and Japanese Boards of Orthodontics. He is currently the Executive Director of the Japanese Association of Orthodontists. He also maintains a private orthodontic practice in Tokyo, Japan. He graciously thanked the college for bestowing this exceptional honor on him and his coauthor.

The editorial board and staff of the *American Journal of Orthodontics* and *Dentofacial Orthopedics* as well as the officers and members of the College of Diplomates of the American Board of Orthodontics congratulate this dedicated individual for his contributions to the orthodontic profession.

2013 College Annual Meeting Scientific Program Overview

As the 2013 Scientific Program Chair, it is my pleasure to invite you to participate in the scientific program for the upcoming CDABO meeting in Bermuda. The theme of this year's meeting is "Orthodontic Technology: How it impacts our daily practice".

With the advent of 3-D imaging technology, the use of CBCT, laser, model scanners, digital impression and TADs in our offices, there is no doubt technology can impact our daily practice. CDABO has prepared 8 speakers in four half days with cutting edge information to prepare our members to meet this challenge.

Dr. Kate Vig, Professor Emeritus of the Department of Orthodontics, The Ohio State University will give supporting evidence on the technological advancements and clinical practice. Dr. Martin Palomo, Professor of the Department of Orthodontics, Case Western University will update our members on the use of CBCT technology in clinical practice.

The program will continue with Dr. Henry Fields, Professor and Chair of the Department of Orthodontics, The Ohio State University, who will provide new information on the use of new esthetic appliance

and wires together with CBCT in the treatment of impacted maxillary teeth. Dr. Chung-Hau Kau, Professor and Chair of the Department of Orthodontics, University of Alabama will update us on how modifying biology can change our approach to orthodontic treatment such as in the case of accelerated orthodontic treatment.

On the third day, Dr. Jay Bowman, who is an international and national speaker on the topic of skeletal anchorage will show us why we should not be afraid of using TAD in our practice. Dr. Steve Harrison of Rollo, Missouri, who is a regular speaker on our AAO program, will update our members on the use of radiosurgery for soft tissue management.

On the final day, Dr. Dave Musich of Schaumburg, Illinois, who is also a visiting Professor at the University of Pennsylvania, will speak on the treatment of congenitally missing maxillary lateral incisor with the latest technology. Dr. Roberto Hernandez Orsinis of Guayama, Puerto Rico will increase our envelope of treatment planning by using the latest advance in technology.

I look forward to seeing you all in Southampton, Bermuda and learning from this diverse group of experts we have been fortunate to bring together.

ABO/CDABO Resident Advocacy Program Update

The state of the s

The American Board of Orthodontics and the College of Diplomates of the American Board of Orthodontics have formed a joint committee to develop a program to encourage ABO certification in the orthodontic residency programs.

The ABO Directors attempt to visit each residency program at least every three years but a local positive presence to encourage ABO certification would be very meaningful. The committee has recruited volunteer advocates for ABO certification to make yearly presentations to the residents in each of the orthodontic programs.

The main core of the program is a PowerPoint presentation that describes the ABO certification process, the ABO, and CDABO. This presentation will be accessed through the ABO website. The content will be reviewed annually by the ABO and CDABO to insure accuracy. Also provided will be a Board Case Oral Exam (BCOE) sample case to allow diagnosis and treatment planning as done during the oral exam. Alan Moffitt's ABO website videos on the Discrepancy Index – DI

and cast scoring, would also be used to help resident's experience measuring DI and cast finishing scores on either sample cases or cases they are working on.

We plan to survey the advocates to determine what works well with our program, what can be modified, and importantly what strategies work at their program to encourage certification. The results would be available to all the advocates as a resource.

We wish to thank and acknowledge the advocates who have volunteered to participate in the program. We currently have all of the graduate programs (72) covered except the University of Toronto. We have 84 advocates committed to help with our program at this time.
